use the materials for any commercial purpose, or for any public display (commercial or non-commercial);

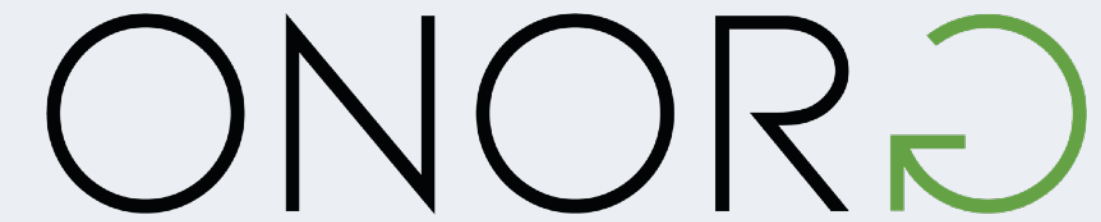

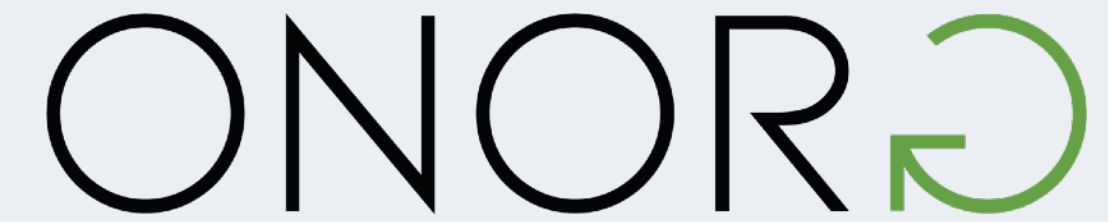
4. Limitations
